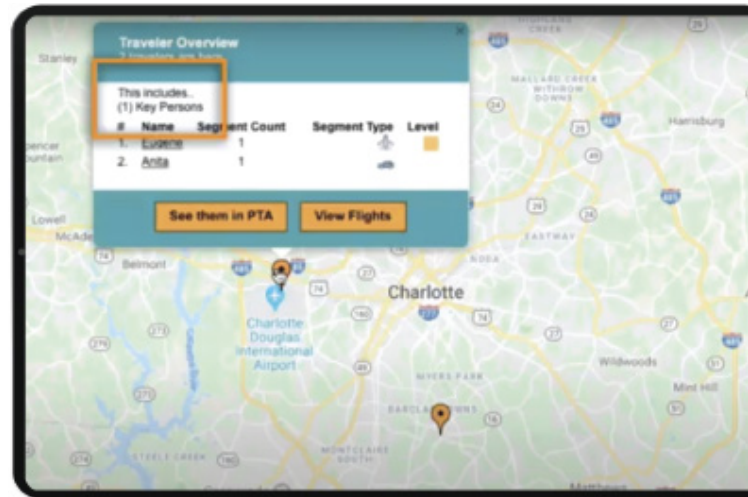

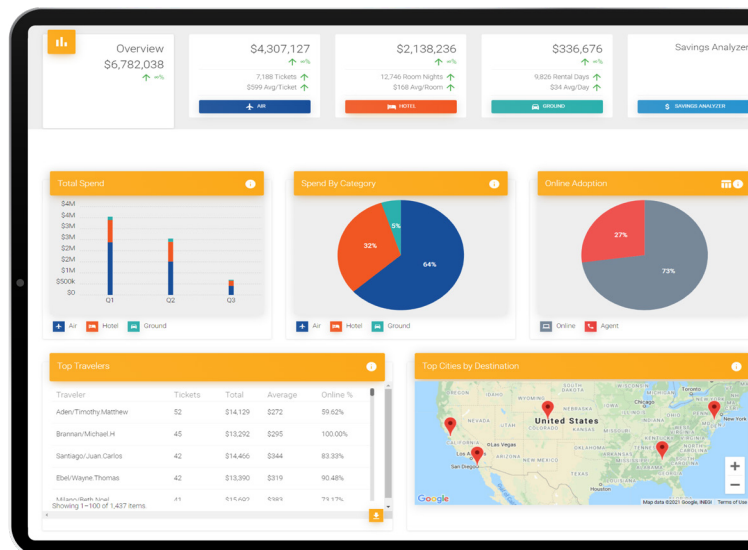
Traveler Tracking and Duty of Care
